The animal is spayed/neutered and has its current vaccinations.

I/we agree to care for this animal humanely which includes providing adequate food, water, shelter, love and attention. Said animal shall be maintained in an adequately enclosed area while at your residence. Cats shall not be allowed to roam at will. The OOHS understands that one of the pleasures of living in a rural area is the ability to allow cats to accompany you unleashed during recreation and working situations. If the cat responds to training and can be positively controlled without a leash, I/we shall maintain visual and/or verbal contact with the cat while unleashed and shall not allow the cat to roam unattended. I/we agree to have the cat vaccinated annually with necessary inoculations and vaccinated against rabies in accordance with local/state ordinances. I/we agree to provide essential veterinary care as needed. If said animal becomes lost or stolen, I/we agree to notify OOHS immediately at (541) 943-3368.

I/we agree not to sell, trade or dispose of this animal. If, at any time, I/we are unable or unwilling to care for this cat, I/we agree to contact and return said cat to OOHS. The adoption fee will not be refunded after 10 days from adoption date of \_\_\_\_\_. We also agree that OOHS will keep one half of the adoption fee if the cat is returned within a period of ten days. I/we further agree that said cat shall not be used for medical or any other experimental purposes or sold or given to a pet store, supplier or wholesaler.

I/we agree the animal shall not be used for any illegal purposes. If this clause is broken, I/we agree that the animal will be immediately confiscated by OOHS and all law enforcement agencies will be notified as applicable.

I/we agree to notify OOHS within 10 days of any change of address or phone number. It is also understood that OOHS may examine and make inquiries about said animal at any time. If not satisfied with the condition of the animal or the conditions in which the animal is kept the animal can and may be removed immediately and placed in a different home. Any veterinary services needed due to negligence or lack of care will be the adopters' responsibility and payable to the service provider.

I/we understand that OOHS makes no guarantees or warranties regarding the health or temperament of this animal. I/we promise and agree to be solely responsible for this animal and identify and hold harmless OOHS from any and all claims of liability for the conduct of this animal on or after the date of this adoption. This RELEASE OF LIABILITY and INDEMNIFICATION shall apply to all known, unknown and unanticipated damages resulting from my/our adoption, ownership or control of such animal.
